Arthrobacter phage Amigo was enriched from soil from Spring (TX, USA) on *Arthrobacter* sp. ATCC 21022 on which the phage produced plaques with a clear center with a large halo around it. The phages of this genus possess terminally redundant genomes with direct repeats of approximately 1584–1589 bp. BLASTN, CoreGenes (Table 1) [2], and phylogenetic analyses (Fig. 2) [3] all indicate that the proposed genus, *Amigovirus*, is cohesive and distinct from other genera. On average, the genomes of members of this genus are 59.0 kb in length (53.0 mol% G+C), and encode 86 proteins and 7 tRNAs.

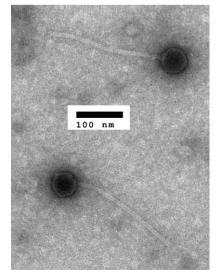

Phylogenetic analysis of (A) large subunit terminase proteins and (B) major capsid proteins of Arthrobacter phage Amigo-like viruses and homologous proteins from a variety of other phages constructed using "one click" at phylogeny.fr [3]. "The "One Click mode" targets users that do not wish to deal with program and parameter selection. By default, the pipeline is already set up to run and connect programs recognized for their accuracy and speed (MUSCLE for multiple alignment and PhyML for phylogeny) to reconstruct a robust phylogenetic tree from a set of sequences." It also includes the use of Gblocks to eliminate poorly aligned positions and divergent regions. "The usual bootstrapping procedure is replaced by a new confidence index that is much faster to compute. See: Anisimova M., Gascuel O. 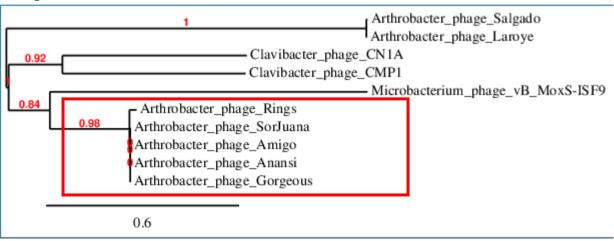


Figure 1: Phylogenetic tree.

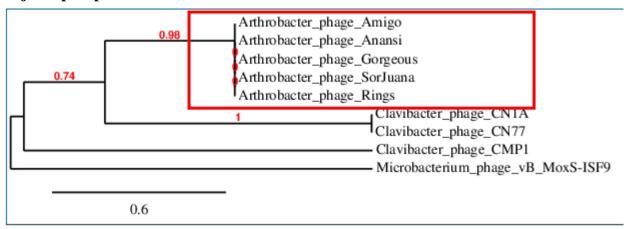


Figure 1: Phylogenetic tree.
