*Edwardsiella tarda* lytic bacteriophages KF-1 and IW-1 are members of the *Podoviridae* [4]. They were isolated from Japanese flounder kidney (*Edwardsiella* phage KF-1) and seawater (*Edwardsiella* phage IW-1).

BLASTN, CoreGenes (Table 1) [2], and phylogenetic analyses (Fig. 1) [3] all indicate that the proposed genus, *Kf1virus*, is cohesive and distinct from other genera. On average the genomes of members of this genus are 41.6 kb in length (48.3 mol% G+C), and encode 48 proteins and 0 tRNAs.

**Fig. 1.** Phylogenetic analysis of large subunit terminase proteins of kf1 viruses and a variety of other homologous phage proteins constructed using “one click” at phylogeny.fr [3]. "The "One Click mode" targets users that do not wish to deal with program and parameter selection. By default, the pipeline is already set up to run and connect programs recognized for their accuracy and speed (MUSCLE for multiple alignment and PhyML for phylogeny) to reconstruct a robust phylogenetic tree from a set of sequences." It also includes the use of Gblocks to eliminate poorly aligned positions and divergent regions. "The usual bootstrapping procedure is replaced by a new confidence index that is much faster to compute. See: Anisimova M., Gascuel O. 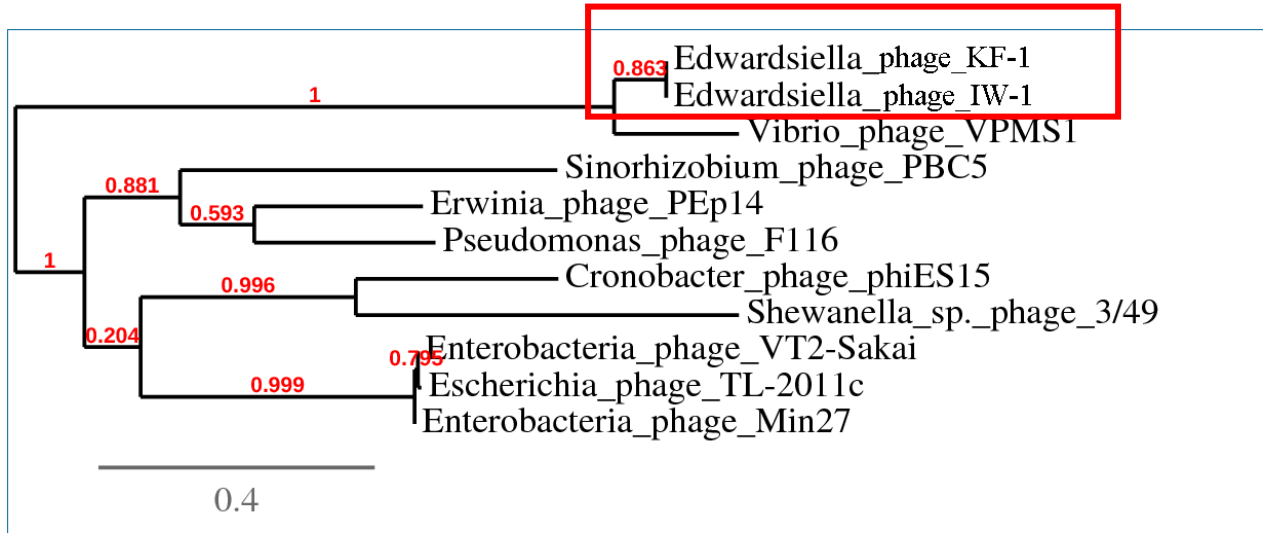


Figure 1: Phylogenetic tree (the branch length is proportional to the number of substitutions per site).
